For example, my great-great-grandfather, Baron Lothar von Faber, co-founder of one of the first workplace kindergartens, also constructed company housing and supported schools. My father, Count Roland von Faber-Castell, continued this charitable work and spoke emphatically of the "law" of his forefathers that a company must also act with social responsibility. In March 2000 I signed the Faber-Castell Social Charter which applies world-wide and includes, for example, the ban on child labour.
